#### V. Legislative Update

Mr. Winters shared the Legislative Update, April 2022 – this document can be found in the shared drive. SB 955 - Would include as an excused absence from school for any middle school or high school student participating in a civic or political event for one day per year. SB 1057 - Deletes the requirement of suspension or delay in the issuance of a driving privilege in the mandatory truancy notice.

#### VI. Updates from State SARB

Mr. Winters reviewed the Attendance Awareness Campaign 2022 Webinar Series. Information can be found in the shared drive. The first webinar took place on April 6<sup>th</sup>, additional webinars are available.

Mr. Winters shared information on SB 830; proposed at this time, it is a finance supplemental education bill. LCFF if based on average daily membership instead of average daily attendance. What is being said is that districts should have funding regardless if students attend.

Mr. Winters shared information on the K12 Omnibus Trailer Bill. Information can be found on the shared drive.

Mr. Winters gave an update on the Model SARB Recognition Program. Six districts statewide were recognized. Mr. Winters has joined the sub committee and will update the team as information is shared.

#### VII. SARB Member Questions/Insights/Best Practices/Training Needs

Mr. Winters opened the floor to anyone in the group with comments or questions. Mrs. Byrne shared that she attended a JJCC meeting. The Thrive program was brought up at the meeting, it was shared that this is a great program. The need for therapists and public health nurses was discussed. It is recognized that there is a great need for these positions.

Dr. Hernandez Williams shared that a team member has asked what others are doing to bring students to school. Asked if anyone has sample letters that are not a notification letter, but a letter to promote attendance. Does anyone have an outside the box way to encourage families with attendance? It was mentioned that Attendance Works has a lot of resources; flyers and maybe even letters that may go out at the beginning of the school year to promote attendance. Dr. Bradley mentioned engaging A2A postcards and/or newsletters. Mr. Winters shared that Moorpark has a pre-SARB letter that they send out to families. The letter includes information that is pulled from attendance works; it's a more positive letter. Mr. Winters will share the letter.
