- School closures due to COVID-19 related staffing shortages occurring during the time period of September 1, 2021 to June 30, 2022 are qualifying events with additional conditions, for which Form J-13A requests may be submitted. The additional conditions that must be met when submitting Form J-13A requests for COVID-19 related staffing shortages are as follows:
- o The LEA is unable to provide in-person instruction to students due to staffing shortages as a result of staff quarantine due to exposure to, or infection with, COVID-19 pursuant to local or state public health guidance.
 - o For certificated staff shortages, the LEA has exhausted all options for obtaining staff coverage, including using all certificated staff and substitute teacher options, **and has consulted with their county office of education** and the California Department of Education (CDE) in determining that staffing needs cannot be met through any option.
 - o For classified staff shortages, the LEA has exhausted all options for obtaining staff coverage, including using all staff options, **and has consulted with their county office of education** and the CDE in determining that staffing needs cannot be met through any option.

2. Federal Provision Participation Requirement
3. Supplemental State Meal Reimbursement

State Meal Mandate Update:

- Beginning in SY 2022–23:
 - Provide breakfast **and** lunch to **all** students

Federal Meal Provision Requirement:

- ***High poverty*** schools that are eligible for the Community Eligibility Provision (CEP) must apply for a federal provision
- May apply for CEP ***or*** another Provision

Determine if the Provision Requirement Applies:

1. Calculate your Identified Student Percentage (ISP)

$$\frac{\text{\# of directly certified students}}{\text{\# of total enrolled students}} \times 100$$

Determine if the Provision Requirement Applies:

2. If ISP is 40 percent or greater:

Must apply for CEP or Provision 1, 2, or 3

3. If ISP is below 40 percent:

- Provides state funds to supplement the federal meal reimbursement for breakfasts and lunches served
- Requires participation in School Breakfast Program (SBP) and National School Lunch Program (NSLP) to receive additional state funding

Universal Meals FAQ (1)

Q: When are LEAs required to implement the components of California Universal Free Meals? And what LEAs are required to participate?

A: California Universal Free Meals goes into effect beginning in SY 2022–23 and applies to public school districts, county offices of education and charter schools.

Universal Meals FAQ (2)

Q: What meals can our school serve and claim to fulfill the California Universal Meals Program requirements?

A: LEAs can claim one meal during each meal service, or one breakfast and one lunch served to a student each school day.

Universal Meals FAQ (3)

Q: Our school is low poverty. Are we required to participate in the California Universal Meals Program and receive state reimbursement?

A: Yes, all public schools, county offices of education, and charter schools are required to provide two nutritionally adequate meals.

Universal Meals FAQ (4)

Q: Does the new state meal mandate apply when students are not on campus (i.e., if they are independent study students or attending school virtually)?

A: No, the state meal mandate only applies when students are on campus.

Universal Meals FAQ (5)

Q: Do schools still need to collect free and reduced-price meal applications if all children are receiving free meals?

A: Yes, LEAs participating in the NSLP and SBP will need to collect meal applications. All federal regulations still apply for the determination of eligibility for the NSLP and SBP.

2021-22 Principal Apportionment Data Collection for Charter Schools

Overview

Principal Apportionment Data Collection (PADC) migrated from the desktop software format to a web-based application effective 2021-22 fiscal year. This transition also resulted in changes to the format of the various data entry screens applicable to charter schools.

The December 2022 ESSCO/COFS handout summarized the changes to the data entry screen for First Principal Apportionment reporting period. This handout summarizes the reporting and highlights the changes to charter school attendance since those screens were most impacted by the changes.

Data Entry Screen Changes

- The former stand-alone Charter Status data entry screen has been incorporated into the individual attendance data entry screens.
- The two former screens used for reporting attendance served by charter schools operating county programs have been consolidated into one data entry screen, Attendance County Program Charter School.

Please see the December 2021 ESSCO/COFS handout for a detailed list of all data entry screens and summary of changes. Additionally, the PADC User Manual, available at <https://www.cde.ca.gov/fg/sf/pa/> provides comprehensive information about every data entry screen in the PADC.

Attendance Reporting Screens

Charter schools must report attendance, using one of three data entry screens, based on the type of charter school. A blank sample of each data entry screen is attached for reference.

The PADC web application filters screen access based on the type of charter school. If the charter school does not have access to the correct data entry screen, users should email PADC@cde.ca.gov as soon as possible to resolve the access issue.

Attendance Reporting Summary

Charter Status

- The separate data entry screen has been retired.
- Charter Status is now part of the attendance reporting screens:
 - Attendance Charter School screen
 - Attendance Charter School – All Charter District
 - Attendance County Program Charter School
- Data collected:
 - Single Track or Mutlitrack
 - Date Instruction Commenced, by track; only required for newly operational charter schools.
 - Date Operation/Instruction Ceased, by track; only required if school ceased operation during the fiscal year.

- Days of Operation, by track; only required at P-1 and P-2 if school ceased operation during the fiscal year; required for all charter schools at Annual.
- Type of Instruction.

Average Daily Attendance (ADA) Reporting by Track

- All schools report ADA for Single Track/Track A.
- Charter schools operating multiple instructional tracks report ADA in the additional track records, which are preset in the system. This is now required at P-1, P-2, and Annual
- ADA reporting by instructional setting:
 - Former: report Total ADA and Classroom-based ADA, system calculated Nonclassroom-based ADA.
 - New: report Classroom-based ADA and Nonclassroom-based ADA, system calculates Total ADA, classroom-based charter schools only report one set of data.

ADA Allocation by District of Residence

Attendance Charter School:

- Only applicable to countywide charters approved pursuant to *EC* Section 47605.6 and charters approved by the State Board of Education pursuant to *EC* Section 47605(k)
- Data is used for calculation of in-lieu of property taxes.

Attendance County Program Charter School:

- Only applicable to charter funded ADA.

Summary

- New tab totaling ADA reported by track and by district of residence, if applicable

Main Validation Rules

- The PADC requires multi-track charters to assign tracks in alphabetical sequence, and warns the user if the ADA is not reported for all tracks chosen or if ADA is reported for a track not chosen.
- Any instruction commencement or cessation dates must be within specified ranges.
- The total ADA reported for all tracks must equal to the total ADA reported by district of residence, if applicable.
- Charters reporting ADA in the TK/K-3 grade span should report any Transitional Kindergarten ADA.
- ADA reported by district of residence should match the grade levels served by the school district.

- ADA reported in the Other ADA category may not exceed Reported ADA for each track, as specified.

The attachments represent blank templates for the charter school attendance screens. They are provided for reference for users that may need to see the screen layouts and data lines without having to log on to the PADC.
