- Public Health Ms. Jimenez stated that flu season is here and encourages everyone to get a flu vaccine. Ms. Jimenez will email Aurelia a few County sites and Aurelia will share with the group.

- Community Partners Mr. Bernal, Grizzly Youth Academy shared information about their program. He shared that they work with at risk students, ages 16-18. They offer a 17.5 month long residential program.

• They track their graduates for one year after graduation. Students gain credits while attending Grizzly Youth Academy.

The program has grown tremendously over the years. Mr. Bernal invited the group to visit grizzlyyouthacademy.org. Enrollment information is listed on the website.

Dr. Hernandez Williams shared that while working at Channel Islands HS, she had the opportunity to attend a Grizzly Youth Academy presentation and found it very inspiring. There are opportunities to become mentors for these students. Dr. Hernandez Williams suggested contacting Mr. Bernal and invite him or his team to present to students and talk to staff about what they offer. Mr. Winters asked that flyers be sent to Aurelia and she will add them to the shared drive.

Ms. Partido, Outreach Specialist from Interface Children & Family Services, shared the youth shelter continues to provide services. She shared the 24/7 Outreach phone number 805.469.5882.

### V. SARB Member Questions/Insights/Best Practices

Mr. Winters shared that SB 14 goes into effect immediately, as it was signed by the governor on October 8<sup>th</sup>. Students will be excused when ill due to mental or behavioral health. Moorpark reviewed their Administrative Regulation. If excessive absences are called in by a parent, a letter is sent out to the parent. Dr. Hernandez Williams asked if the Board Policy should also be reviewed. Ms. Bowman asked if there is a new code in Q to differ these illnesses for tracking purposes. Ms. Steed stated that it all would depend on what each district's system allows. Ms. Steed shared that if the absences for mental health need to be tracked separately from regular illness absences, a different code would be needed. She added that it also depends on how each district's system is set up. Ms. McWaters agreed that the districts will want to separate the absences. Ms. Steed asked that the notes section not be used to track this information. Ms. Jimenez asked if students with the mental health illness need a medical note. Mr. Winters stated that every district has different regulations. He explained Moorpark's regulations and added that Moorpark changed their Administrative Regulation to state "excessive" absences. It was suggested that staff have conversations early on with parents to get a health plan in place for the student.

Dr. Nocero stated that the district and staff have an obligation to identify a child with a disability. Dr. Hernandez Williams added a link in chat box for SB 14 information.

Mr. Winters shared information from Ms. Pujol, Gateway, regarding Julian Valenzuela. The Student was last enrolled at Gateway and has not returned since Sept. 7, 2021. Mr. Winters asked that information regarding this student be emailed to Aurelia and she will forward to Mr. Pujol.
