VENTURA COUNTY BOARD OF EDUCATION MINUTES OF REGULAR MEETING OF SEPTEMBER 25, 2017

A. CALL TO ORDER

- <u>Call to Order, Pledge of Allegiance to the Flag, and Moment of Reflection</u> The Regular Meeting of the Ventura County Board of Education, Agenda 17-11, was called to order by Dr. Ramon Flores, Board President at 6:00 p.m. on Monday, September 25, 2017, in the Board Room of the VCOE Conference & Educational Services Center, 5100 Adolfo Road, Camarillo. Dr. Lisagor moved that the Board approve Consent Item 6. Mr. Kunicki seconded the motion, and the motion carried upon a unanimous vote (5:0).

K. PRESENTATIONS

1. <u>Proclamation No. 17-08, Honoring the work of Dr. Joe Mendoza, Director,</u> <u>Special Populations Educational Support</u>

Dr. Mendoza indicated that he is humbled by this honor. He recognized those who work with him, the coordinators and staff, who support his efforts. He further thanked the Administrators – Mr. Mantooth; Dr. Rice; Dr. Castor and Ms. Key for their support and encouragement; and their Executive Assistants for their hard work. Additionally, he thanked the County Board for their spirit of collaboration, support and culture of respect. The Speech and Debate Tournament began in Ventura County with the support of the County Office of Education and the Board. This tournament is now administered and fully funded by the State.

Dr. Flores presented a Proclamation to Dr. Joe Mendoza, Director, Special Populations Educational Support, for his service to the Ventura County Office of Education and the students of Ventura County.

L. DISCUSSION/INFORMATION/ACTION

- 1. <u>Review of 2017-18 Courses of Study for Career Education Center Program</u> <u>PUBLIC HEARING and Approval of Resolution 17-07 Regarding</u> <u>Sufficiency/Insufficiency of Instructional Materials, and Certification of Provision</u> <u>of Standards-Aligned Instructional Materials</u>
 - a. Dr. Flores opened the PUBLIC HEARING on Resolution 17-07 regarding the sufficiency/insufficiency of instructional materials at 6:44 p.m.

Hearing no comments, Dr. Flores closed the PUBLIC HEARING at 6:45 p.m.

b. Mr. Mantooth reported that the Office does have sufficient instructional materials for its students this year. Dr. Lisagor moved the Board adopt Resolution 17-07 regarding Sufficiency/Insufficiency of Instructional Materials, and the accompanying Positive Certification of Provision of Standards-Aligned Instructional Materials. Mr. Kunicki seconded the motion, and the motion carried upon a unanimous vote (5:0).

2. <u>Annual Programmatic Audit Presentation by Vista Real Charter High School</u> (VRCHS)

Dr. Rice introduced Marlo Hartsuyker, new Director of Charter School Support and Oversight. She previously served as the lead petitioner and Board President for MATES Charter School. She is also a trained attorney.

Corinne Manley presented the Annual Programmatic Audit for Vista Real Charter High School (VRCHS). VRCHS currently operates Resource Centers in Oxnard, Santa Paula, Ventura (2), Simi Valley, Camarillo and Port Hueneme.

VRCHS was formerly an ASAM school and has applied for the new California School Dashboard Alternative Schools Status (DASS). 74% of students qualify for at least one of these qualifications.

Enrollment is 1040 this year. Majority of students are 17 and older and at 10th grade level by credits. The ethnicity compares with other districts. 78% socioeconomically disadvantaged; 16% special education students; 76% Hispanic. ELL are at 13%.

Student Success includes engagement in school. 26% return to their school; 64% remain at VRCHS. VRCHS has added more support staff as needed, including 4 counselors, 7 credentialed special education teachers and 3 ELD teachers. There have been no expulsions since the school opened and 1 suspension in 2016-17. Financials include \$23,711,944 in revenue with an ending balance of \$3 million.

LCAP Goals

Goal #1 – Student Retention

Student retention, attendance rate of 85%, drop out rate low, suspension and expulsion rates are low and school facilities are maintained.

Goal #2 – Credit Completion

Credit Completion rate has increased; ELL reclassification rate has increased; all teachers highly qualified and graduation rate has increased.

Goal #3 – Computer Literacy

Online course enrollment and completion has increased significantly.

Goal #4 - College and Career Readiness

CTE Courses offered; students have academic plans; every student takes a professional skills course and a computer skills course; percentage of students meeting or exceeding the standards in ELA and Math has increased. 46% of VRCHS graduates enrolled in college within the first year.

Goal #5 – Stakeholder Involvement

Participation in Open House and Awards is increasing. Work continues on getting parents involved in PAC; parent conferences are well attended; and students feel safe, connected and are satisfied with the program. New course offerings have been added including student leadership and athletics – cross-country and soccer.

Parent Satisfaction efforts include frequent communication home, award nights, parent conferences, and newsletters.

Work cooperatively with local school districts continues to be a goal. Meetings held with counselors and district administrators in surrounding districts. Summer School partnerships and community partnerships.

Ms. Ulrich asked about the projected increase in revenue and its cause. Ms. Manley will report back on this.

Dr. Flores asked who the Board members are: Victoria Hancock; Sean Leonard; Ernie Villegas; and Randy Morris.

Mr. Kunicki suggested that Mr. Mantooth discuss VRCHS with the new VUSD Superintendent. Mr. Mantooth noted that staff will be holding an orientation for the new Superintendents of Ventura and Ojai Unified School Districts. The orientation will include an overview of the Charter Schools within Ventura County.

- Adoption of 2017-18 Courses of Study for Career Education Center Program Ms. Ulrich moved the Board adopt the 2017-18 Courses of Study for Career Education Center Program as presented. Mr. Bates seconded the motion, and the motion carried upon a unanimous vote (5:0). Ms. Ulrich commended the designer of the catalog.
- 4. <u>Review of Objectives in Support of Ventura County Board of Education Goals</u> Mr. Mantooth noted that the annual review of the Superintendent's salary and progress towards the Office Goals is usually presented at this time. The Office is at the midpoint of their two-year cycle in pursuit of Focus Areas adopted, and therefore will not be presenting a review of the work of the County Office this year.

Mr. Mantooth noted that a poster containing the County Office of Education Vision, Mission and Goals is now located in every conference room. The one in the Board Room is a depiction of the Board's Vision, Mission and Goals.

Ms. Ulrich suggested revisions to Objectives under Goal #1 to Career Pathways and work with the Ventura County Community College District.

Mr. Bates suggested that a Sub Committee be established to review the goals and objectives thoroughly and bring any recommended changes to the Board. Dr. Flores named Ms. Ulrich and himself to this subcommittee which will meet in mid to late October. Mr. Mantooth invited the subcommittee to contact the Office for any assistance. The current goals and objectives will stand until revised.
