SUBJECT: Weapons and Dangerous Instruments		

The Board desires students and staff to be free from the fear and danger presented by firearms and other weapons. The Board prohibits any person other than authorized law enforcement or security personnel from possessing weapons, imitation firearms, or dangerous instruments of any kind in school buildings, on schools grounds or buses, at school-related or school-sponsored activities away from school, or while going to or coming from school.

Given the need to maintain order and discipline in the schools and to protect the safety of students, staff and the public, any school employee is authorized to confiscate a weapon, dangerous instrument or imitation firearm from any person on school grounds.

Students possessing or threatening others with a weapon, dangerous instrument or imitation firearms are subject to suspension and/or expulsion in accordance with law, Board policy and administrative regulations.

The principal or designee shall notify law enforcement authorities when any student possesses, displays, sells, or otherwise furnishes a firearm at school or at a school event.

The principal shall immediately suspend, pursuant to California Education Code section 48911, and shall recommend the pupil's expulsion to the County Superintendent any student found at school or at a school activity to be:

1. Possessing, as verified by a district employee, displaying, selling or otherwise furnishing a firearm, unless the student had obtained prior written permission to possess the item from a certificated school employee with the principal or designee's concurrence.

Upon finding that the student committed the above act, the County Superintendent shall expel the student.

Expulsion orders are appealable to the county board of education in accordance with California Education Code Section 48919.
