MINUTES

1. Call to Order and Pledge of Allegiance

The meeting of the Ventura County Committee on School District Organization was called to order by Chairperson Charles Weis to the Ventura County Committee on School District Organization, at 4:30p.m. at the Conejo Valley Unified School District, Board Room.

2. Chairperson Charles Weis led the group in the pledge of allegiance.

3. Introduction of County Committee Members

4. **Public Comments**

Chairperson Charles Weis asked if there were any public comments. There were none.

5. **Information about Conejo Valley Unified School District's Desired Change in Election**

Dr. Mark McLaughlin thanked the County Committee for coming to Conejo Valley Unified School District (CVUSD) and appreciated their time. Dr. McLaughlin shared that the district serves students in Southeastern Ventura County in the Thousand Oaks vicinity and there are approximately 19,000 students. Throughout the process, the district has been, and continues to be, committed to transparency and educating its residents with public meetings and hearings. Dr. McLaughlin explained that on June 11, 2018, CVUSD received a demand letter from an attorney alleging the Districts' elections violate the California Voting Rights Act (CVRA). On November 20, 2018 the CVUSD Board was provided an update and background on the CVRA and the CVSUD Board adopted a resolution to:

- Initiate transition to by-trustee area election system
- State intent to seek waiver of election requirement from State Board of Education

Jonathan Salt explained that the district was required to have a total of five public hearings, two before any maps were drawn and three before a final decision could be made. Mr. Salt explained the Community Outreach – Meeting Schedule:

- November 20, 2018, information
- December 4, 2018, pre-map public hearing
- December 11, 2018, pre-map public hearing
- January 22, 2019, public hearing on map options
- February 5, 2019, public hearing on map options
- February 19, 2019, public hearing on map options

Mr. Salt shared that at the beginning of the process Dr. McLaughlin sent letters home after Thanksgiving break in both English and Spanish to the students explaining what the process was and how it was not going to have an impact on the election that occurred on November 6, 2018. This letter provided all of the public hearing dates so folks would know when the meetings were scheduled. The Districts social media posted Dr. McLaughlin's letters as well as every time there was a Board meeting on this subject, when maps were released and the public hearings. The District posted the final map that the Board adopted.

Newspaper reporters from the Ventura County STAR and the Thousand Oaks Acorn were at most of the meetings. There were at least eleven articles published by the reporters from when the District received their letter until the final adoption and a few thereafter. The District put together a very comprehensive website in English and Spanish.

Larry Ferchaw presented on requirements in establishing Trustee voting areas:

Federal and State Requirements

- Federal Requirements
 - *Equal Population*

 - No Discriminatory Purpose; No vote dilution

 - Community of Interest

Adopted Plan: Demographics

There are approximately 135,000 residents as of the 2010 Census which means five roughly equal areas of 27,000 people.

Mr. Ferchaw provided nine possible demographic scenarios: Scenarios 1, 2, 3, 2A, 3A, 3B, D1, D2 and D3. Scenario 3A was selected by the CVUSD District Board members and received the most community response towards being the favorite. Map 3A was submitted by members of the community and is a variation of the original Scenario 3.

Robert Perez asked if there were many Latinos that came to speak to the Board. Dr. McLaughlin answered that there were some Latino parents and students that spoke to the Board.

6. PUBLIC HEARING:

Chairperson Charles Weis opened the public hearing on CVUSD's change in election system pursuant to Education Code Section §5019(c)(1) at 4:55p.m. Chairperson asked if the public wished to make a statement. No comments from the public were made.

Chairperson Charles Weis closed the public hearing at 4:56 p.m.

7. PUBLIC HEARING:

Chairperson Charles Weis opened the public hearing on CVUSD's request that the State Board of Education waive the election requirements of Education Code Sections §5020 and §5030 at 4:56 p.m. Chairperson asked if the public wished to make a statement. No comments from the public were made.

Chairperson Charles Weis closed the public hearing at 4:57 p.m.

8. Discussion and Action:

A motion was made by Rob Collins to adopt County Committee resolution 19-02 approving the establishment of trustee areas and changing the method of election to a by-trustee area election process in the CVUSD. Motion was seconded by Kathi Smith.

Chairperson Charles Weis called for the vote. Motion passed unanimously.

COUNTY COMMITTEE RESOLUTION NUMBER 19-02

RESOLUTION OF THE VENTURA COUNTY COMMITTEE ON SCHOOL DISTRICT ORGANIZATION APPROVING THE ESTABLISHMENT OF TRUSTEE AREAS AND CHANGING THE METHOD OF ELECTION TO A BY-TRUSTEE AREA ELECTION PROCESS IN THE CONEJO VALLEY UNIFIED SCHOOL DISTRICT

WHEREAS, a proposal to establish trustee areas and change the method of election to a by-trustee area election process was presented to the Ventura County Committee on School District Organization (“County Committee”) by the Board of Education (“Board”) of the Conejo Valley Unified School District; and

WHEREAS, the Board of the Conejo Valley Unified School District has adopted a resolution declaring its intent to seek a waiver of the election requirements from the State Board of Education; and

WHEREAS, Education Code section §5019(c)(1) provides that a proposal to establish trustee areas may be initiated by resolution of the governing board of a district; and

WHEREAS, Education Code section §5019(c)(2) further provides that when a proposal is made by a governing board of a district to establish trustee areas, the county committee on school district organization shall call and conduct at least one hearing in the district on the matter; and

WHEREAS, Education Code section §5030 provides that whenever trustee areas are established in a district, provisions shall be made for one of the alternative methods of electing governing board members; and

WHEREAS, Education Code section §5020 provides that a resolution of a county committee on school district organization approving a proposal to establish trustee areas, and to adopt one of the alternative methods of electing governing board members specified in Education Code section §5030, shall constitute an order of election which shall be presented to the electors of the district not later than the next succeeding election for members of the governing board; and

WHEREAS, the County Committee met on March 22, 2019, to consider the proposal to establish trustee areas and change the method of election to a by-trustee area election process in the Conejo Valley Unified School District; and

WHEREAS, the County Committee meeting on March 22, 2019, took place within the boundaries of the Conejo Valley Unified School District, and the meeting included a public hearing in accordance with Education Code section §5019(c); and

WHEREAS, by Resolution Numbers 18/19-11 and 18/19-17, the Board of the Conejo Valley Unified School District determined that an at-large method of election could be subject to legal challenge under the California Voting Rights Act of 2001 and adopted a by-trustee area electoral system for consideration by the County Committee; and

WHEREAS, by Resolution Number 18/19-18, the Board of the Conejo Valley Unified School District declared its intent to request that the State Board of Education waive the election requirements of Education Code section §5020 and §5030 in order to ensure the timely adoption of trustee areas and the district’s transition from its current at-large electoral process; and

WHEREAS, having consideration of the proposal of the Board of the Conejo Valley Unified School District to establish trustee areas and change the method of election to a by-trustee area election process as set forth in its Resolution Numbers 18/19-11 and 18/19-17, as well as public comments, the County Committee recommends approval of the proposal of the Board of the Conejo Valley Unified School District;

NOW, THEREFORE, BE IT RESOLVED that the County Committee hereby finds the foregoing recitals to be true and correct; and

BE IT FURTHER RESOLVED the County Committee hereby establishes trustee election areas within the Conejo Valley Unified School District as set forth in the District's Resolution Numbers 18/19-11 and 18/19-17; and

BE IT FURTHER RESOLVED the County Committee hereby adopts, as the method of election governing board members to the Board of Education of the Conejo Valley Unified School District, that method of election specified in Education Code section §5030(b), which provides one or more members residing in each trustee area be elected by the registered voters of that particular trustee area; and

BE IT FURTHER AND FINALLY RESOLVED that this action of the County Committee establishing trustee election areas and adopting one of the alternative methods of electing governing board members specified in Education Code section §5030 shall not be deemed to constitute an order of election if the State Board of Education grants the district's waiver and if such waiver is granted, trustee area elections shall be commenced effective the next succeeding Board member election in November 2020.



**RESOLUTION OF THE GOVERNING BOARD
OF THE CONEJO VALLEY UNIFIED SCHOOL DISTRICT
Resolution No. 18/19-11**

**Resolution to Initiate a Transition to a By-Trustee Area Election System Commencing
with the 2020 Governing Board Election and Statement of Intent to Seek a Waiver of the
Election Requirement from the State Board of Education**

WHEREAS, the Conejo Valley Unified School District Board of Education ("Board") is keenly aware of the importance of maintaining a fair election system;

WHEREAS, the Board has always strived to listen to all voices in the community and represent all of our community;

WHEREAS, California Education Code sections 5019(a) & (c)(1) and 5030 authorizes the Ventura County Committee on School District Organization ("County Committee"), upon application of a school district's governing board, to change the method of election of governing board members in a school district under its jurisdiction;

WHEREAS, the California Voting Rights Act (Elections Code §§ 14025 *et seq.*) ("CVRA") prohibits the use of an "at-large" election system for governing board members of a school district if the "at-large" elections impair the ability of a protected class to elect candidates of its choice, or its ability to influence the outcome of an election;

WHEREAS, Governing Board ("Board") Members of the Conejo Valley Unified School District ("District") are currently elected using an "at-large" election system (i.e., election system in which registered voters of the entire jurisdiction elect candidates to the governing board);

WHEREAS, the Board received a letter from a law firm asserting that the Board's at-large board member electoral system violates the CVRA and threatening litigation if the Board declines to voluntarily change to a district-based election system for electing board members;

WHEREAS, although the letter was not accompanied by any evidence to support the claim of a CVRA violation, the Board has directed staff to initiate the process to establish "by-trustee areas" elections to avoid costs associated with defending a lawsuit based on the CVRA even if that lawsuit were to reach a settlement in a timely manner;

WHEREAS, there was inadequate time for the District to complete the required transition process, obtain community input, and work with the County and State to implement a change to by-trustee area elections in advance of the November 2018 general election;

WHEREAS, it is considered the view of the Board that starting with the 2020 Board elections, and with the benefit of federal Census data, the public interest will be better served by election of its Board members using a "by-trustee area" election system (i.e., elections in which one candidate residing in each trustee area is elected by only the registered voters in that particular trustee area);

WHEREAS, although Education Code section 5020 requires that a County Committee's resolution approving a change in the method of electing governing board members be submitted to the electorate for its approval at the school district's next regular election, the Board intends to seek a waiver of the voter approval requirement as permitted by law. Education Code sections 33050-33053 authorize the State Board of Education to waive this voter approval requirement, which could reduce the costs and risks associated with a school district's transition to a "by-trustee area" election system;

WHEREAS, the Board finds it is appropriate to seek a waiver of the election requirement in Education Code section 5020, and portions of sections 5019, 5021, and 5030, to ensure the timely implementation of the "by-trustee area" election system commencing with the 2020 Governing Board election, to reduce costs for the District associated with placing an item on the ballot and to reduce any potential legal liability or financial risk to the District under the CVRA;

WHEREAS, the adoption of "by-trustee area" elections will not affect the terms of any sitting Board members, or the terms of any Board candidates who are elected during the November 2018 election, each of whom will serve out his or her current term; and

WHEREAS, the Board, cognizant of its need for fiscal responsibility, desires to implement this change in the manner of electing Board members in the most cost effective and efficient manner.

NOW, THEREFORE, the Governing Board of the Conejo Valley Unified School District does hereby resolve, order and determine as follows:

1. The above recitals are true and correct.
2. The Board hereby determines that the trustee area boundary lines shall be developed based on federal Census data to provide for "by-trustee areas" elections commencing in 2020.
3. By this resolution, and pursuant to Education Code sections 5019(a) and 5030, the Board directs District staff to transmit this resolution to the Ventura County Committee on School District Organization to apply to have the County Committee adopt a change in the method of electing members of the board from "at-large" elections [Education Code section 5030(a)] to "by-trustee area" elections [Education Code section 5030(b)] commencing with the 2020 Board elections.
4. Before submitting a final proposal to the County Committee for a trustee area plan using the federal Census data, multiple public hearings shall be scheduled to obtain public input on the draft proposals prepared.
5. The Board shall apply to the County Committee for establishment of trustee areas pursuant to Education Code section 5019(a) in a timely manner to have the 2020 elections for the Board conducted within the new trustee areas.
6. The Superintendent, or his designee, shall send a copy of this resolution to the County Committee for action in accordance with law.

7. The Superintendent, or his designee, is hereby directed to prepare an additional Board resolution, and implement the applicable legal requirements in a timely manner, to seek a waiver from the State Board of Education of the election requirement imposed by Education Code section 5020.
8. The Superintendent, or his designee, shall consult with legal counsel to resolve all legal issues necessary to give effect to this resolution.
9. The foregoing resolution shall take effect immediately upon its adoption.



**RESOLUTION OF THE GOVERNING BOARD

Resolution #18/19-17**

A RESOLUTION APPROVING AND ADOPTING A FINAL TRUSTEE AREA PLAN FOR THE DISTRICT'S TRANSITION TO A BY-TRUSTEE AREA ELECTION SYSTEM; A PLAN OF ELECTION FROM THOSE AREAS; AND RECOMMENDING THAT THE VENTURA COUNTY COMMITTEE ON SCHOOL DISTRICT ORGANIZATION APPROVE THE DISTRICT'S ESTABLISHMENT OF A BY-TRUSTEE AREA ELECTION SYSTEM AND ADOPTED TRUSTEE VOTING AREA PLAN

A. On November 20, 2018, the Conejo Valley Unified School District Governing Board ("Board") passed Resolution No. 18/19-11 initiating the process for the Conejo Valley Unified School District ("District") to transition from an "at-large" election system to a "by-trustee area" election system commencing with the 2020 Board elections.

B. In approving Resolution No. 18/19-11, the Board expressed its view that a transition to a by-trustee area election system will reduce the District's risk of costly litigation, especially since a successful plaintiff under the California Voting Rights Act (Elections Code §14025 *et seq.*) ("CVRA") is entitled to reasonable attorneys' fees and experts' fees, creating great financial risk to any jurisdiction sued.

C. The District utilized the services of Cooperative Strategies ("Consultant") to prepare proposed trustee area boundary plans for consideration by the District, Board, and community. The Consultant has extensive experience working with school districts and local jurisdictions regarding electoral demographics, taking into consideration the CVRA, the Federal Voting Rights Act, and related election system choices.

D. All of the proposed trustee area boundary plans prepared by Consultant were drawn with all applicable laws and regulations in mind, including the CVRA and federal election law.

E. The District conducted public hearings at Board meetings on December 4, 2018 and December 11, 2018 to solicit feedback in advance of map preparation. The map options were released to the public and available for public review and comment on the District's website from mid-January 2019 until final adoption on February 19, 2019. During that time, the District conducted public hearings at Board meetings on January 22, 2019, February 5, 2019, and February 19, 2019. The District also continuously posted FAQs, map options, presentation materials, and additional information materials on the District's website page devoted specifically to this transition.

F. With thoughtful consideration of all public input received on the draft trustee area plans and applicable state and federal legal criteria, the Board desires to adopt the trustee area plan and demographic information described as the "Trustee Plan 3A (attached hereto as Exhibit "A") as the final trustee area plan establishing the boundaries for the new trustee areas, and to request timely approval from the County Committee of the trustee area plan and the District's transition to a by-trustee area election system commencing with the 2020 Governing Board election.

G. In order to complete the transition to by-trustee area elections in a timely and cost effective manner, and to ensure that the new by-trustee area process will be in place in time to elect new governing board members at the Board's next regularly scheduled election, the District is seeking a waiver of certain portions of the Education Code from the State Board of Education. The District's request for waiver will be submitted to the State Board of Education for approval.

NOW, THEREFORE, the Governing Board of Conejo Valley Unified School District does hereby resolve, order and determine as follows:

1. The above recitals are true and correct.
2. The Board hereby adopts the trustee area plan and demographic information described as the 3A Map Option (attached hereto as Exhibit "A") as the final trustee area map for the District's transition to a by-trustee area election system commencing with the 2020 Governing Board election.
3. That the District will hold by-trustee area elections in two areas (areas 1 and 5) at its November 2020 election, assuming timely approval by the Ventura County Committee. The District will hold by-trustee area elections in three areas (areas 2, 3, and 4) at its November 2022 election subject to any required trustee area boundary adjustments required pursuant to Education Code section 5019.5 following the release of the decennial federal census.
4. That by this resolution and contingent upon the approval by the County Committee of the District's change to a by-trustee area election system, the Board hereby applies to the County Committee to timely approve the Board's adopted trustee area plan for implementation commencing with the 2020 Governing Board election, or at the earliest possible election, as conditioned upon approval of the Education Code waiver request submitted to the State Board of Education.
5. The Board hereby authorizes and directs District staff to transmit this resolution, the final trustee area plan adopted, and any additional required documentation to the County Committee and to take any other necessary action to effectuate the purposes of this resolution and complete the District's transition to a by-trustee area election system for the 2020 Governing Board elections.
6. The foregoing resolution shall take effect immediately upon its adoption.



**RESOLUTION OF THE GOVERNING BOARD
OF THE CONEJO VALLEY UNIFIED SCHOOL DISTRICT
Resolution No. 18/19-18**

**Resolution Authorizing the Submission of a General Waiver Request to be Approved by
the State Board of Education Concerning the District's Transition to a By-Trustee Area
Election System**

A. On November 20, 2018, the Conejo Valley Unified School District Governing Board ("Board") passed Resolution No. 18/19-11 initiating the process for the Conejo Valley Unified School District ("District") to transition from an "at-large" election system to a "by-trustee area" election system commencing with the 2020 Board elections.

B. The Board believes that a transition to a by-trustee area election system will reduce the District's risk of costly litigation, especially since a successful plaintiff under the California Voting Rights Act ("CVRA") is entitled to reasonable attorneys' fees and experts' fees, creating great financial risk to any jurisdiction sued.

C. Although Education Code section 5020 normally requires a resolution approved by the local county committee on school district organization authorizing a change in the method of electing governing board members be submitted to the electorate for its approval at the District's next regular election, the State Board of Education is authorized to waive section 5020(a) and portions of sections 5019, 5021, and 5030 of the Education Code related to such election requirement.

D. Further, in passing Resolution No. 18/19-11, the Board expressed its intention to seek a waiver of the ballot requirement from the State Board of Education as permitted under Education Code sections 33050-33053. By seeking a waiver from the election requirement, the District will make sure the new by-trustee area election system is implemented by the 2020 Governing Board election, thereby reducing the risk of any potential liability to the District under the CVRA, in addition to reducing costs for the District associated with placing an item on the ballot.

E. In order to obtain a waiver from the State Board of Education, the District must comply with Education Code sections 33050 and 33051 and State Board of Education and California Department of Education regulations and requirements. Such requirements include conducting a noticed public hearing whereby the public may testify on the merits of obtaining a waiver from the State Board of Education and submitting a completed General Waiver Request form to the California Department of Education to be approved by the State Board of Education. Such requirements further include contacting the District bargaining units, advisory committees and councils.

F. On March 5, 2019, during a meeting of the Board, the Board convened a duly-noticed public hearing to solicit public testimony on the merits of obtaining a waiver of the election requirement from the State Board of Education.

NOW, THEREFORE, the Governing Board of the Conejo Valley Unified School District does hereby resolve, order, and determine as follows:

1. The above recitals are true and correct.
2. That after receiving and considering public testimony at a duly-noticed public hearing, the Board hereby approves the application of a General Waiver Request, to be approved by the State Board of Education, seeking waiver of Education Code Section 5020 and portions of Sections 5019, 5021, and 5030, pertaining to the requirement that a change in the District's election system from an "at large" election system to a "by-trustee area" election system be presented to the electorate of the District.
3. That the District has consulted all collective bargaining units and shall note the collective bargaining units' positions regarding the waiver in the District's General Waiver Request.
4. That the District has consulted with all applicable advisory committees and councils regarding the waiver and shall note such consultation in the District's General Waiver Request.
5. The Board hereby authorizes and directs the Superintendent, or his designee, to submit a General Waiver Request to the California Department of Education, to be approved by the State Board of Education, seeking a waiver from the election requirement imposed by the Education Code sections noted herein, so as to ensure the timely implementation of the District's by-trustee area election system for the 2020 Governing Board elections, and to take all actions necessary to effect the intent of this resolution.
6. The foregoing resolution shall take effect immediately upon its adoption.

OVERVIEW

The Conejo Valley Unified School District currently elects its Board of Education members through an at-large election system. Under this system, candidates for the Board of Education can reside anywhere in CVUSD's area of service and are elected by the registered voters that reside within CVUSD's area of service.

CVUSD received a [demand letter dated June 8, 2018](#) claiming that the District's current method of electing the Board of Education members through at-large elections violates the [California Voting Rights Act \("CVRA"\)](#). This letter alleges that the District's elections "may be occurring by polarized voting," and threatens litigation if the District declines to adopt a By-Trustee Election System. A By-Trustee Election System is one in which CVUSD's area of service is divided into By-Trustee areas, and voters in each By-Trustee area choose their Board of Education representative, who must also live in that By-Trustee area.

On November 20, 2018, Conejo Valley Unified School District Board of Education members adopted a [resolution](#) declaring their intent to transition to a By-Trustee Area Election System in response to the demand letter.

Pursuant to [Election Code Section 10010](#), CVUSD will conduct a series of public hearings over the next 90 days to receive community input on the composition of proposed election geographic areas for Board of Education seats. It is of the utmost important that residents participate and provide feedback during the upcoming public hearings. It is the District's desire to ensure that the proposed By-Trustee Areas reflect communities of interest and that the community is involved in this process.

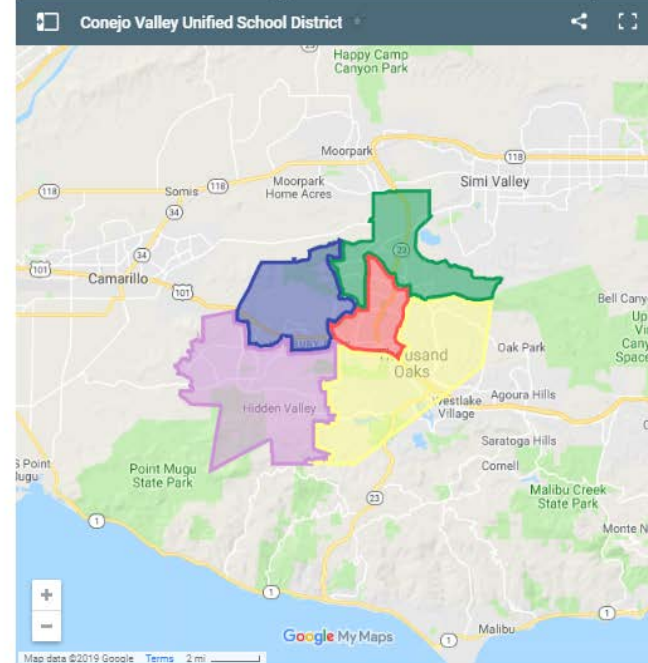

When will the 2020 U.S. Census data be considered for the formulation of the By-Trustee Area Election System maps?

Adjustments to the By-Trustee Area maps would need to be considered and adjusted in 2021 based on the 2020 U.S. Census data results.

Following each decennial federal census, Education Code 5019.5 specifically requires school districts with trustee area elections to adjust boundaries of any or all trustee areas of the district to ensure that one or both of the following conditions is satisfied:

- (1) The population of each area is, as nearly as may be, the same proportion of the total population of the district as the ratio that the number of governing board members elected from the area bears to the total number of members of the governing board.
- (2) The population of each area is, as nearly as may be, the same proportion of the total population of the district as each of the other areas.

(Education Code section 5019.5(a).)

The District is required to make any such adjustment by the first day of March of the year following the release of the new decennial census data. Therefore, the current census is used for the 2020 election but, depending on potential population growth and movement depicted via the 2020 census, the trustee area map lines may need to be adjusted to achieve equal population in advance of the 2022 election.

What if there is no candidate in one of the By-Trustee Areas?

There is a limited, 25 day window for candidates to file declarations of candidacy with the County Registrar to run for office. There is a limited, 25 day window for candidates to file declarations of candidacy with the County Registrar to run for office. This narrow window opens 113 days prior to the election and closes 88 days prior to the election. If no qualified candidate emerges from a Trustee area up for election, the Board may appoint to fill the vacancy from a resident of that Trustee area.

Unlike ordinary appointments, according to Education Code section 5326, if no candidate has been nominated by 83 days prior to the election, the Board is authorized to appoint a qualified person to the Board. Such appointment must occur at a Board meeting prior to election day and the appointed member will be "seated" to the Board at the organizational meeting. Unlike, most vacancies, vacancies and appointments due to failure to elect result in the appointee serving "as if elected" – for the full term. *(Education Code section 5328.)*

The District's Board Bylaw ("BB") No. 9223 (Filling Vacancies) describes the process for finding qualified candidates to appoint. Specifically, the District is required to advertise in the local media to solicit candidate applications or nominations and a committee consisting of less than a quorum of the Board shall ensure that applicants are eligible for Board membership and announce the names of the eligible candidates. The Board shall interview the candidates at a public meeting, accept oral or written public input, and select the provisional appointee by a majority vote. (BB No. 9223; see also Education Code section 5328.5.)

In sum, should no qualified candidate emerge, starting at the close of business on the 83rd day prior to election day, the District will begin to advertise the open seat within the relevant Trustee-area and form a committee of less than a quorum of the Board (2 Board members). Importantly, the appointee must be eligible for office and reside within the specific vacant trustee area. The appointment must be made at a Board meeting prior to election day. The appointed member will serve as if elected in the general election – for four years.

Why is CVUSD being divided into five By-Trustee Areas, instead of three or seven or nine?

Pursuant to Education Code section 35012, the default number of trustees for a given school district is five. In certain circumstances, a unified school district may be formed with, or increase its number of trustees to, seven members. Also, elementary school districts with daily attendance of under 300 students are permitted to have as few as three trustees. While there is a process that permits school districts to move from five to seven or from seven to five trustees, here, the recent and ongoing transition to a By-Trustee Area Election System does not impact the number of trustees representing and governing the District. Instead, this transition only alters the method by which trustees are elected. Since CVUSD is governed by a five Trustee Board, the draft map options each create five Trustee areas.

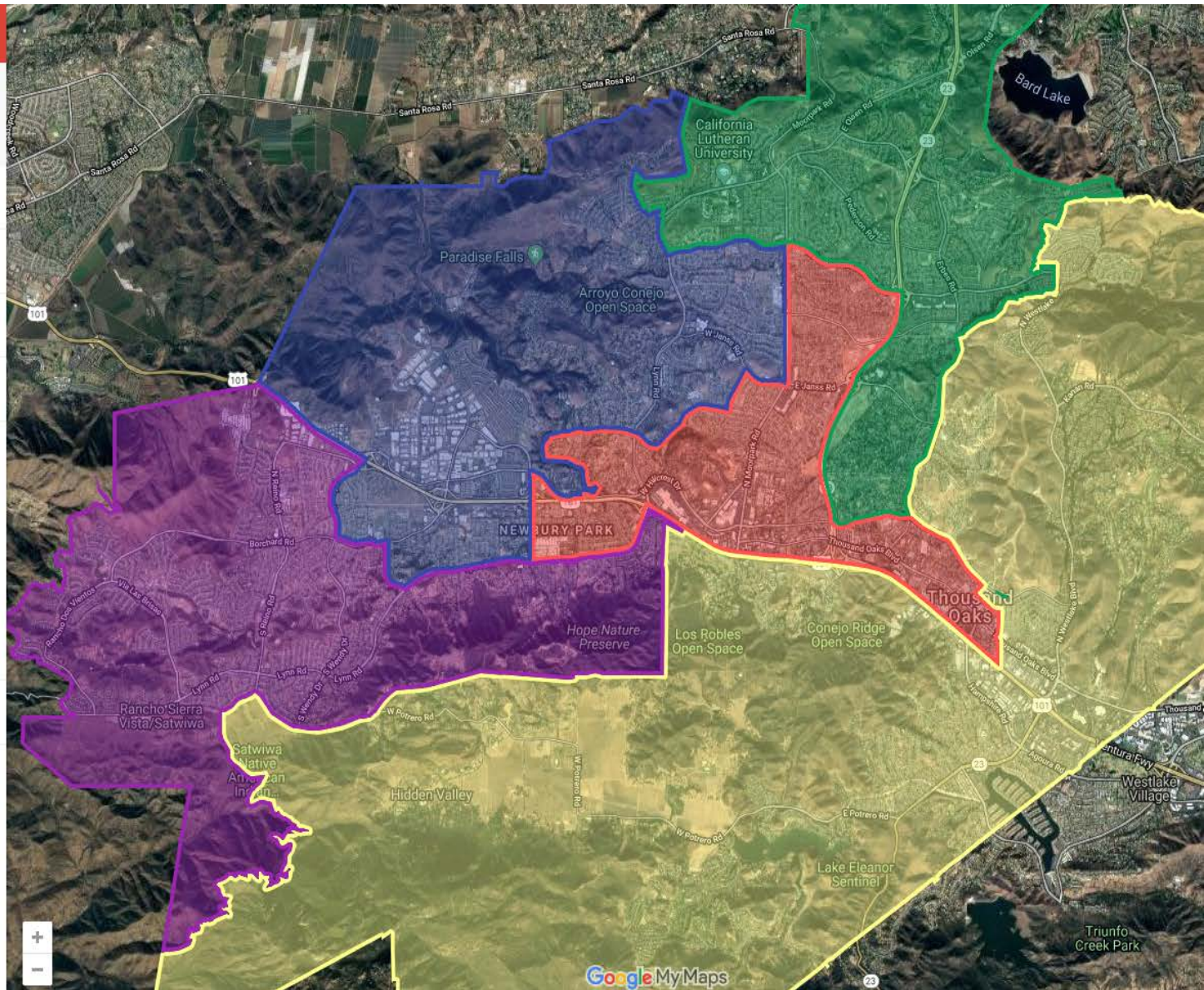

Elecciones basadas en el distrito

El Distrito Escolar Unificado de Conejo Valley actualmente elige a sus miembros de la Junta de Educación a través de un sistema electoral general. Bajo este sistema, los candidatos para la Junta de Educación pueden residir en cualquier parte del área de servicio de CVUSD y son elegidos por los votantes registrados que residen dentro del área de servicio de CVUSD.

CVUSD recibió una carta de [demanda con fecha del 8 de junio de 2018](#) en la que se afirma que el método actual del Distrito para elegir a los miembros de la Junta de Educación a través de elecciones generales infringe la Ley de [Derechos de Votación de California \("CVRA"\)](#). Esta carta alega que las elecciones del Distrito "pueden estar ocurriendo por votación polarizada" y amenaza con un litigio si el Distrito se niega a adoptar un Sistema de Elecciones de los Fideicomisarios. Un Sistema de Elección de los Fideicomisarios es aquel en el que el área de servicio de CVUSD se divide en áreas de los Fideicomisarios, y los votantes en cada área de los Fideicomisarios eligen a su representante de la Junta de Educación, que también debe vivir en esa área.

El 20 de noviembre de 2018, los miembros de la Junta de Educación del Distrito Escolar Unificado de Conejo Valley adoptaron una [resolución](#) que declaraba su intención de hacer la transición a un Sistema de Elecciones del Área de los Fideicomisarios en respuesta a la carta de demanda.

De conformidad con la [Sección 10010 del Código Electoral](#), CVUSD llevará a cabo una serie de audiencias públicas durante los próximos 90 días para recibir comentarios de la comunidad sobre la composición de las áreas geográficas de la elección para los puestos de la Junta de Educación. Es de suma importancia que los residentes participen y proporcionen comentarios durante las próximas audiencias públicas. El deseo del Distrito es asegurar que las Áreas de los Fideicomisarios propuestas reflejen las comunidades de interés y que la comunidad esté involucrada en este proceso.
