SUBJECT: Uniform Complaint Procedures

The Governing Board and Superintendent recognizes its role in developing policies to comply with applicable state and federal laws and regulations governing the Ventura County Office of Education's (VCOE) educational programs. The Governing Board encourages the early, informal resolution of complaints whenever possible and appropriate. To resolve complaints which cannot be resolved through such informal process, the Governing Board adopts the uniform system of complaint processes specified in 5 CCR 4600-4670 and incorporates any Superintendent-approved procedures implementing this policy.

According to state and federal codes and regulations, the programs and activites subject to the Uniform Complaint Procedure (UCP) are:

- After School Education and Safety
- Agricultural Career Technical Education
- American Indian Education Centers and Early Childhood Education Program Assessments
- Bilingual Education
- California Peer Assistance and Review Programs for Teachers
- Career Technical and Technical Education; Career Technical; Technical Training (State)
- Career Technical Education (Federal)
- Child Care and Development
- Child Nutrition
- Compensatory Education
- Consolidated Categorical Aid
- Course Periods without Educational Content
- Economic Impact Aid
- Education Of Pupils In Foster Care, Pupils Who Are Homeless, Former Juvenile Court Pupils Now Enrolled In A School District, and Pupils Of Military Families
- Every Student Succeeds Act / No Child Left Behind (Titles I–VII)
- Local Control and Accountability Plans (LCAP)
- Migrant Education

- Physical Education Instructional Minutes
- Pupil Fees
- Reasonable Accommodations to a Lactating Pupil
- Regional Occupational Centers and Programs
- School Safety Plans
- Special Education
- State Preschool
- Tobacco-Use Prevention Education

The VCOE Uniform Complaint Procedures (UCP) shall be used to investigate and resolve the following complaints:

- 1. Any VCOE complaint alleging violation of applicable state or federal law or regulations governing adult education programs, after school education and safety programs, migrant education, career technical and technical education and training programs, child care and development programs, child nutrition programs, special education programs, consolidated categorical aid programs, or any other implemented program which is listed in Education Code 64000(a)
- 2. Any complaint alleging the occurrence of unlawful discrimination (such as discriminatory harassment, intimidation, or bullying) against any person participating in VCOE programs and activities, including, but not limited to, those programs or activities funded directly by or that receive or benefit from any state financial assistance, based on the person's actual or perceived characteristics of race or ethnicity, color, ancestry, nationality, national origin, ethnic group identification, age, religion, marital, pregnancy, or parental status, physical or mental disability, sex, sexual orientation, gender, gender identity, gender expression, or genetic information, or any other characteristic identified in Education Code 200 or 220, Government Code 11135 or Penal Code 422.55, or based on his/her association with a person or group with one or more of these actual or perceived characteristics
- 3. Any complaint alleging VCOE noncompliance with the requirement to provide reasonable accommodation to a lactating student on school campus to express breast milk, breastfeed an infant child, or address other breastfeeding-related needs of the student
- 4. Any complaint alleging VCOE noncompliance with the prohibition against requiring students to pay fees, deposits, or other charges for participation in educational activities, as defined in Education Code 49010
- 5. Any complaint, by or on behalf of any student who is a foster youth, alleging VCOE noncompliance with any legal requirement applicable to the student regarding placement decisions, the responsibilities of the VCOE's educational liaison to the student, the award of credit for coursework satisfactorily completed in another public school, school transfer, or the grant of an exemption from any additional graduation requirements

- 6. Any complaint, by or on behalf of a homeless student as defined in 42 USC 11434a or a former juvenile court school student and pupils in military families, as defined in Education Code 51225.2, alleging VCOE noncompliance with any requirement applicable to the student regarding the award of credit for coursework satisfactorily completed in another public school or the grant of an exemption from any additional graduation requirements
- 7. Any complaint alleging VCOE noncompliance with the requirements of Education Code 51228.1 and 51228.2 that prohibit the assignment of a student to a course without educational content for more than one week in any semester or to a course the student has previously satisfactorily completed, without meeting specified conditions
- 8. Any complaint alleging VCOE noncompliance with the physical education instructional minutes requirements for students in elementary school
- 9. Any complaint alleging retaliation against a complainant or other participant in the complaint process or anyone who has acted to uncover or report a violation subject to this policy
- 10. Any other complaint as specified in a Governing Board policy or a Superintendent policy

All complainants shall be protected from retaliation and the confidentiality of the parties involved shall be protected as required by law.

Records of all UCP complaints and the investigations of those complaints are to be maintained in accordance with applicable law and Superintendent policies and procedures.

NON-UCP COMPLAINTS

The following complaints shall not be subject to the VCOE's UCP but shall be referred to the specified agency:

- 1. Any complaint alleging child abuse or neglect shall be referred to the County Department of Social Services, the County Protective Services Division, and the appropriate law enforcement agency.
- 2. Any complaint alleging fraud shall be referred to the California Department of Education.

In addition, the Superintendent's Williams Uniform Complaint Procedures shall be used to investigate and resolve any complaint related to sufficiency of textbooks or instructional materials, emergency or urgent facilities conditions that pose a threat to the health or safety of students or staff, or teacher vacancies and misassignments.
